Upon acceptance of the aforesaid bid by the Woods Hole, Martha's Vineyard and Nantucket Steamship Authority (hereinafter referred to as the "Owner"), the undersigned agrees to enter into a Contract with the Owner in the form of the Pro-Forma Contract referred to above within ten (10) calendar days after notice of acceptance of its bid and at that time also furnish the requisite payment bond in an amount equal to at least fifty percent (50%) of the Total Contract Price. The surety or sureties on such bonds shall be satisfactory to the Owner. The undersigned further agrees to pay the premiums for the aforesaid payment bond and that all the cost of such bonds and the premiums therefor is included in the amount of the foregoing bid.

The undersigned further agrees: (a) that it will not withdraw the foregoing Bid prior to the expiration of thirty (30) days after the date fixed for the opening of bids under the IFB; and (b) that in the event of the expiration of said thirty (30) day period without an award of the Contract having been made, the foregoing Bid shall remain in full force and effect for another thirty (30) days unless and until the Owner receives written notice of the withdrawal of the foregoing Bid by the undersigned.
